ASSIGNMENT AGREEMENT

This Agreement is made and entered into the 1st day of January, 1990, by and between Pacific Coast Mines, Inc., a Delaware corporation ("Assignor") and Kennecott Exploration Company, a Delaware corporation ("Assignee").

WITNESSETH

For the good and valuable consideration of Ten Dollars (\$10.00), the receipt of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee, and Assignee hereby accepts said assignment and transfer, of all of Assignor's right, title and interest in and to (i) that certain Mining Lease dated the 12th day of August, 1985, as amended, by and between Assignor and JoAnn K. Wilson, a resident of Reno, Nevada, W.L. Wilson, Joan Wilson and William G. Waldeck, residents of Grand Junction, Colorado (the "Agreement"), which Agreement is subject to that certain 1979 Nevada Tungsten Project Agreement dated January 1, 1979, as amended, by and between Assignor and Knox-Kaufman, Inc., and (ii) the mining claims (the "Property") made the subject thereof, and more particularly described in Exhibit "A" attached hereto and made a part hereof.

Assignee agrees to assume, pay and perform all of the covenants and obligations of Assignor under the Agreement which accrue subsequent to the effective date hereof, and to stand in the place and stead of Assignor with respect thereto.

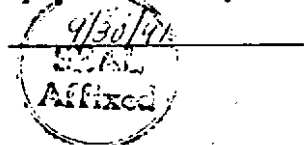
