QUITCLAIM DEED

TOGETHER WITH all dips, spurs and angles, in and to all the ores, mineral-bearing quartz, rock and earth or other deposits therein or thereon, and in and to all of the rights, privileges and franchises thereto incident, and in and to all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the rents, issues and profits thereon; and also in and to all the estate, right, title, interest, property, possession, claim and demand whatsoever, as well in law as in equity, of the said Grantor, of, in or to the Premises and every part and parcel thereof, with the appurtenances, including all after-acquired title.

TO HAVE AND TO HOLD, all and singular, the said Premises, together with the appurtenances and privileges thereto incident unto the said Grantee, its successors and assigns forever.
