Corner No. 6 is a 5 foot long x 3 inch diameter, solid, capped PVC post

The monumentation and marking of the corners was completed by the 19th day of January, 19 91.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
