CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ALPHA 79 Lode Mining Claim on this 3rd day of February, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE (SW) (Quarter) Section(s) 36 (30) Township 32 N, Range 49E (50E), Mt. Diablo Mer., and is more particularly described as follows, to wit:
