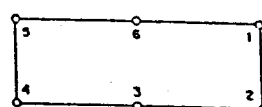
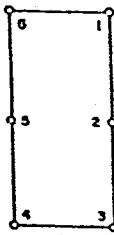

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ALPHA 101 Lode Mining Claim on this 2nd day of February, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(SE)SW (Quarter) Section(s) 25(24)(19), Township 32 North, Range 49(49)(50) East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 600 feet in a south direction to Post No. 2, marked - ALPHA 101 - 2
Thence, 400 feet in a west direction to Post No. 3, marked - ALPHA 101 - 3
Thence, 400 feet in a west direction to Post No. 4, marked - ALPHA 101 - 4
Thence, 600 feet in a north direction to Post No. 5, marked - ALPHA 101 - 5
Thence, 400 feet in a east direction to Post No. 6, marked - ALPHA 101 - 6
Thence, 400 feet in a east direction to Post No. 1, marked - ALPHA 101 - 1

The number of linear feet claimed in length along the course of the vein from the point of discovery is 790 feet in an east direction and 10 feet in a west direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

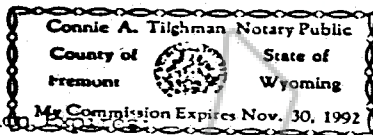
