CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ALPHA 107 Lode Mining Claim on this 2nd day of February, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE(NW) (Quarter) Section(s) 24(19) Township 32 North, Range 49(50) East, Mt. Diablo Mer., and is more particularly described as follows, to wit:
