CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ALPHA 153 Lode Mining Claim on this 1st day of February, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(NW)(SE)(SW) (Quarter) Section(s) 15(14)(10)(11), Township 32 North, Range 49 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 450 feet in a south direction to Post No. 2, marked - ALPHA 153-2
