CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ALPHA 164 Lode Mining Claim on this 5th day of February, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SW (Quarter) Section(s) 4 Township 31 N, Range 49 E, Mt. Diablo Mer., and is more particularly described as follows, to wit:
