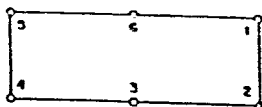
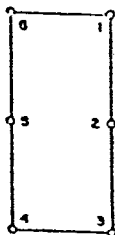

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ALPHA 179 Lode Mining Claim on this 4th day of February, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 4 Township 31 N, Range 49 E, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 660 feet in a south direction to Post No. 2, marked - ALPHA 179 - 2
- Thence, 660 feet in a south direction to Post No. 3, marked - ALPHA 179 - 3
- Thence, 600 feet in a west direction to Post No. 4, marked - ALPHA 179 - 4
- Thence, 660 feet in a north direction to Post No. 5, marked - ALPHA 179 - 5
- Thence, 660 feet in a north direction to Post No. 6, marked - ALPHA 179 - 6
- Thence, 600 feet in a east direction to Post No. 1, marked - ALPHA 179 - 1

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1310 feet in a north direction and 10 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.
