THE PETITION OF THOMAS J. TOMERA and PATSY SUE TOMERA, Guardians of the Person and Estate of the above named Ward, having come before this Court for hearing on the 11th day of June, 1990, at the hour of 9:30 A.M., upon the Petition for Exchange of Property wherein the Guardians have petitioned this Court for its Order authorizing the Guardians to exchange Guardianship assets for the outstanding one-half interest in a note receivable secure by real property; the Court having fully considered the matter and being fully advised in the premises:

THE COURT DOES HEREBY SPECIFICALLY FIND THE FACTS TO BE AS FOLLOWS:

1. That Petitioners are the duly appointed Guardians, and have the authority to invest the Ward's money and to exchange interests in the Ward's real and personal property.

2. That on or about February 14, 1986, TOMERA BROTHERS, a

 Nevada General Partnership consisting of BATTISTA TOMERA and GEORGE TOMERA entered into a sales agreement with JULIAN TOMERA RANCHES, INC., STONE HOUSE DIVISION whereby TOMERA BROTHERS sold and JULIAN TOMERA RANCHES, INC., STONE HOUSE DIVISION purchased certain real property then owned by TOMERA BROTHERS.

- 3. That said sale required the unpaid balance of the purchase price to be paid in ten (10) equal annual installments, with interest on the unpaid balance at the rate of nine (9%) percent per annum.
- 4. That BATTISTA TOMERA died on September 6, 1988; the partnership was dissolved by Court Order entered August 14, 1989, wherein all interests in real property maintained in the name of TOMERA BROTHERS were distributed in equal shares to the ESTATE OF BATTISTA TOMERA and to GEORGE TOMERA.
- 5. That JULIAN TOMERA RANCHES, INC., STONE HOUSE DIVISION has timely made all installment payments which are due pursuant to the Note and Deed of Trust. All payments are current. Six (6) annual installments remain due and owing.
- 6. That GEORGE TOMERA currently has substantial cash assets, which are invested in time deposits which pay interst in varying amounts, none in excess of 8.25%; GEORGE TOMERA also currently holds an undivided one-half interest in the Note secured by real property, above referenced.
- 7. That Petitioners believe that the value of the real property substantially exceeds the unpaid balance of the Note receivable, and is therefore a safe and secure investment.
 - 8. That Petitioners believe that the Ward should purchase

the one-half interest in the Note receivable currently payable to the ESTATE OF BATTISTA TOMERA from the Estate. This purchase would allow the Guardians to invest Guardianship monies at a higher return, providing a greater income to the Ward; any such purchase should be completed prior to distribution of the Estate!

IT IS HEREBY ORDERED that the Guardians shall purchase the outstanding undivided one-half interest in a Note receivable wherein JULIAN TOMERA RANCHES, INC., STONEHOUSE DIVISION is maker and TOMERA BROTHERS is payee, secured by real property from the ESTATE OF BATTISTA TOMERA, for the book value of the asset on the date of purchase.

The Guardians are authorized to execute any and all documents necessary to transfer the interest, and to pay the Guardianships share of any costs and expenses. A copy of this Order shall be recorded in any and all counties necessary to effect the exchange.
