GRANT, BARGAIN AND SALE DEED TO TENANTS IN COMMON

TO HAVE AND TO HOLD the said premises, together with the appurtenances, unto the said Second Parties as joint tenants with right of survivorship and not as tenants in common, and to the survivor of them, and to the heirs, executors, administrators and assigns of the survivor, forever, as to an undivided one-half (%) interest, and unto the said Third Parties, as joint tenants with right of survivorship and not as tenants in common, and to the survivor of them, and to the heirs, executors, administrators, and assigns of the survivor, forever, as to an undivided one-half (%) interest, the Second Parties being tenants in common with the Third Parties.
