CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

NE 1/4 of Section 17, Township 25 N., Range 49 E., M.D.B. & M.

SE 1/4 of Section 17, Township 25 N., Range 49 E., M.D.B. & M.

To tie this claim to the Public Survey, begin at the Northeast Corner of Section 17, Township 25 North, Range 49 East, Mount Diablo Base and Meridian, thence South, approximately 2633 feet and West, approximately 641 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 750 feet from the location monument in a Westerly direction and 750 feet in an Easterly direction, together with 100 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch diameter x 5 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

thence, N. 90°00'E., 750 feet to the North Side Center (Cor. No. 2),

thence, N. 90°00'E., 750 feet to the Northeast Corner (Cor. No. 3),

thence, S. 00°00'E., 600 feet to the Southeast Corner (Cor. No. 4),

thence, S. 90°00'W., 750 feet to the South Side Center (Cor. No. 5),

thence, S. 90°00'W., 750 feet to the Southwest Corner (Cor. No. 6),

thence, N. 00°00'W., 600 feet to the Northwest Corner (Cor. No. 1),

the point and place of beginning.

The monumentation and marking of the corners was completed by the 12th day of March, 1991.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
