CERTIFICATE OF LOCATION FOR LODE MINING CLAIM

NE 1/4 of Section 20, Township 25 N., Range 49 E., M.D.B. & M.
NW 1/4 of Section 21, Township 25 N., Range 49 E., M.D.B. & M.

To tie this claim to the Public Survey, begin at the Northeast Corner of Section 17, Township 25 North, Range 49 East, Mount Diablo Base and Meridian, thence South, approximately 3,833 feet and West, approximately 511 feet to the Northwest corner (Cor. No. 1) of this claim.

We (or I) claim 1,493 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1,483 feet from the location monument in a Southerly direction and 10 feet in a Northerly direction, together with 100 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial 3 inch diameter x 3 foot long plastic post monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is:

Beginning at the Northwest Corner (Corner No. 1),

thence, N. 90°00'E., 600 feet to the Northeast Corner (Cor. No. 2),
thence, S. 00°00'E., 746.5 feet to the East Side Center (Cor. No. 3),
thence, S. 00°00'E., 746.5 feet to the Southeast Corner (Cor. No. 4),
thence, S. 90°00'W., 600 feet to the Southwest Corner (Cor. No. 5),
thence, N. 00°00'W., 746.5 feet to the West Side Center (Cor. No. 6),
thence, N. 00°00'W., 746.5 feet to the Northwest Corner (Cor. No. 1),

the point and place of beginning.

The monumentation and marking of the corners was completed by the 12th day of March, 1991.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
