To tie this claim to the Public Survey, begin at the NW corner of Section 6, Township 19 North, Range 49 East, Mount Diablo Base and Meridian, Thence S 110 41' W, 3059 feet to the Northeast corner of this claim.

The general course of the lode or vein is Northeasterly and Southwesterly.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1490 feet from the location monument in a Northeasterly direction and 10 feet in a Southwesterly direction, together with 100 feet on each side of the center of the ledge for the entire length of the claim.

thence, <u>S 45°E</u>	<u>600</u>	feet to the	<u>Northeast Corner</u> , a 3" in dia. by 5' in length PVC Pipe.
