CERTIFICATE OF LOCATION  
LODE CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has caused to be located the WB 51 lode mining claim on the 12th day of February, 1991.

Said Claim is located in the surveyed NE/4 of Sec. 2 Twp. 19 North, Range 48 East, SE/4 of Sec. 2 Twp. 19 North, Range 48 East, NW/4 of Sec. 2 Twp. 19 North, Range 48 East, SW/4 of Sec. 2 Twp. 19 North, Range 48 East, Mount Diablo Base and Meridian, Eureka County, Nevada.

To tie this claim to the Public Survey, begin at the NW corner of Section 6, Township 19 North, Range 49 East, Mount Diablo Base and Meridian, Thence S 36° 19' W, 9178 feet to the Northeast corner of this claim.

The general course of the lode or vein is Northeasterly and Southwesterly. We ( or I ) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1490 feet from the location monument in a Northeasterly direction and 10 feet in a Southwesterly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC Pipe Monuments, firmly set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:  
thence, S 45° W 750 feet to the East Side Center, a 3" in dia. by 5' in length PVC Pipe,  
thence, S 45° W 750 feet to the Southeast Corner, a 3" in dia. by 5' in length PVC Pipe,  
thence, N 45° W 600 feet to the Southwest Corner, a 3" in dia. by 5' in length PVC Pipe,  
thence, N 45° E 750 feet to the West Side Center, a 3" in dia. by 5' in length PVC Pipe,  
thence, N 45° E 750 feet to the Northwest Corner, a 3" in dia. by 5' in length PVC Pipe,  
thence, S 45° E 600 feet to the Northeast Corner, a 3" in dia. by 5' in length PVC Pipe,  
the point and place of beginning.

The monumentation and marking of the exterior boundaries of this claim was completed on the 18th day of March, 1991.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
