IN WITNESS WHEREOF, MOBIL OIL CORPORATION has caused these presents to be duly executed on this the 22nd day of May, 1991.

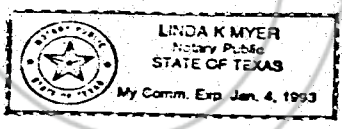
