The location work consisted of making the maps provided in NRS 517.040. Dated May 15 A.D., 19 91, and filed in duplicate.

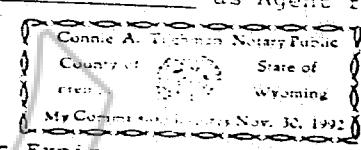
