IT IS HEREBY ORDERED that Judgment be entered in favor of Plaintiff, W. E. VINING CO., INC., a Nevada corporation, and against Defendants NORSE WINDFALL MINES, INC., a Nevada corporation, wholly owned by Eureka Ventures; EUREKA VENTURES, a Texas general partnership consisting of general partners, Norse Minerals, Inc., Viking Minerals, Inc. and Swiss Security System Corporation; NORSE MINERALS, INC., a Texas corporation wholly owned by NORSE PETROLEUM (U.S.), INC., which is a subsidiary of Norse Petroleum, A/S, Norway; VIKING MINERALS, INC., a Nevada corporation, and VEST U.S.A., a Delaware corporation, and a subsidiary of Inspectorate International Finance, N.V. Vest U.S.A. acquired Swiss Security Systems Corporation.

Judgment is awarded in the sum of \$72,115.00 plus interest thereon at 12.0% per annum pursuant to the contract from June 28, 1988, to April 15, 1991, for a pre-Judgment interest in the sum of \$24,224.73 on the \$72,115 for a total of \$96,339.73.

Judgment is further awarded in the sum of \$892,476.81 (\$832,723.47 + \$59,753.34) plus interest thereon at the legal rate from December 16, 1988 through December 31, 1988 at 11.0% per annum; from January 1, 1989 to June 30, 1989 at 12.5% per annum; from July 1, 1989 to December 31, 1989 at 13.0% per annum; from January 1, 1990 to June 30, 1990 at 12.5% per annum; from July 1, 1990 to December 31, 1990 at 12.0% per annum; and from January 1, 1991 to April 15, 1991, at 12.0% per annum for pre-Judgment interest in the sum of \$258,329.34 on the \$892,476.81 for a total of \$1,150.806.15.

Plus court costs in the sum of \$12,015.21 for a total

Judgment in the sum of \$1,259,161.09 and interest thereon from April 15, 1991, until paid at the existing legal rate.

Credit shall be given to said Judgment for any sums paid to LARIAT pursuant to Lariat's Judgment except for court costs and attorney fees in the within matter and additionally the sum of \$15,000 shall be credited thereon when and if Defendants deliver a bill of sale with warranties of title on the said DC-7 caterpillar tractor, serial # 48A09748.
