CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ROGER 1 Lode Mining Claim on this 25th day of March, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE(SW) (Quarter) Section(s) 17(16), Township 35 North, Range 50 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:
