CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ROGER 8 Lode Mining Claim on this 25th day of March, 1991, situated in the Unknown Mining District, Eureka County, Nevada.
