CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ROGER 9 Lode Mining Claim on this 25th day of March, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE(SW) (Quarter) Section(s) 16(16), Township 35 North, Range 50 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Thence, 750 feet in a south direction to Post No. 2, marked - ROGER 9 -2
 Thence, 750 feet in a south direction to Post No. 3, marked - ROGER 9 -3
 Thence, 600 feet in a west direction to Post No. 4, marked - ROGER 9 -4
 Thence, 750 feet in a north direction to Post No. 5, marked - ROGER 9 -5
 Thence, 750 feet in a north direction to Post No. 6, marked - ROGER 9 -6
 Thence, 600 feet in a east direction to Post No. 1, marked - ROGER 9 -1

the point of beginning and all monuments being wood posts.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 1490 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is north and south.

The work of location consisted of making the maps as provided in NRS 517.040. Dated April 10 A.D., 1991, and filed in duplicate.

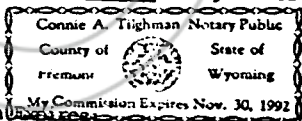
