CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the ROGER 24 Lode Mining Claim on this 26th day of March, 1991, situated in the Unknown Mining District, Eureka County, Nevada.
