CORRECTIVE QUITCLAIM DEED

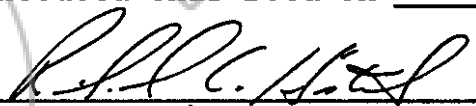

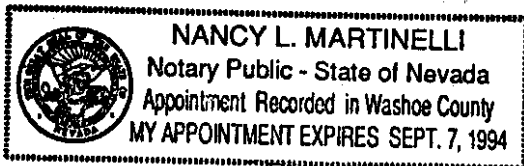
