27 Pursuant to Findings of Fact, Conclusions of Law and good
28 cause appearing therefore,

IT IS HEREBY ORDERED that Judgment be entered in favor of
LARIAT ENTERPRISES, a Nevada corporation, jointly and severally
against Defendants NORSE WINDFALL MINES, INC., a Nevada
corporation, wholly owned by Eureka Ventures; EUREKA VENTURES, a
Texas general partnership consisting of general partners, Norse

1 Minerals, Inc., Viking Minerals, Inc. and Swiss Security System
2 Corporation; NORSE MINERALS, INC., a Texas corporation wholly owned
3 by NORSE PETROLEUM (U.S.), INC., which is a subsidiary of Norse
4 Petroleum, A/S, Norway; VIKING MINERALS, INC., a Nevada
5 corporation, and VEST U.S.A., a Delaware corporation, and a
6 subsidiary of Inspectorate International Finance, N.V. Vest U.S.A.
7 acquired Swiss Security Systems Corporation, and against W. E.
8 VINING COMPANY, INC., a Nevada corporation.

9 Judgment is awarded in the sum of \$59,753.34 plus interest
10 thereon at the legal rate from June 30, 1989. Said interest is
11 from July 1, 1989, to December 31, 1989, at 13.0% per annum; from
12 January 1, 1990, to June 30, 1990, at 12.5% per annum; from July 1,
13 1990, to December 31, 1990, at 12.0% per annum; and from January 1,
14 1991, to April 15, 1991, at 12.0% per annum for a pre-Judgment
15 interest in the sum of \$13,290.93 on the \$59,753.34 for a total of
16 \$73,044.27.

17 Plus attorney fees in the sum of \$15,000.00 and court costs in
18 the sum of \$312.00 for a total Judgment in the sum of \$88,356.27
19 and interest thereon from April 15, 1991, until paid at the legal
20 rate.
