THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HOT SPRING 3 Lode Mining Claim on this 1st day of April, 1991, situated in the Unknown Mining District, Eureka County, Nevada.
