CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HOT SPRING 12 Lode Mining Claim on this 1st day of April, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW(SW) (Quarter) Section(s) 36(36), Township 30 North, Range 46 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:
