### CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HOT SPRING 19 Lode Mining Claim on this 1st day of April, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE (Quarter) Section(s) 36 Township 30 North, Range 48 East, Mt. Diablo Mer. and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a south direction to Post No. 2, marked - HOT SPRING 19 -2

the point of beginning and all monuments being Wood Posts.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 1490 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is north and south.
