CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HOT SPRING 22 Lode Mining Claim on this 1st day of April, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SW (Quarter) Section(s) 36, Township 30 North, Range 48 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 600 feet in a south direction to Post No. 2, marked - HOT SPRING 22 -2
Thence, 450 feet in a west direction to Post No. 3, marked - HOT SPRING 22 -3
