The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a N 1° E direction and 1105 feet in a S 1° W direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N 1° E and S 1° W.
