CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HOT SPRING 59 Lode Mining Claim on this 1st day of April, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW(SW) (Quarter) Section(s) 14(14), Township 29 North, Range 48 East, Mt. Diablo Mer. and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a <u>S 2° W</u> direction to Post No. 2, marked - <u>HOT SPRING 59 -2</u>
Thence, 750 feet in a <u>S 2° W</u> direction to Post No. 3, marked - <u>HOT SPRING 59 -3</u>
Thence, 600 feet in a <u>N 89° W</u> direction to Post No. 4, marked - <u>HOT SPRING 59 -4</u>
Thence, 750 feet in a <u>N 2° E</u> direction to Post No. 5, marked - <u>HOT SPRING 59 -5</u>
Thence, 750 feet in a <u>N 2° E</u> direction to Post No. 6, marked - <u>HOT SPRING 59 -6</u>
Thence, 600 feet in a <u>S 89° E</u> direction to Post No. 1, marked - <u>HOT SPRING 59 -1</u>

the point of beginning and all monuments being Wood Posts.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a N 2° E direction and 1490 feet in a S 2° W direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N 2° E and S 2° W.

To tie this Claim to the Public Survey, begin at the Northeast corner, Section 14, Township 29 N., Range 48 E., Mt. Diablo Mer., and bear S 2° W, 1500 feet and N 89° W, 3000 feet to the northeast corner of this Claim.

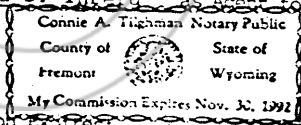
