CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HOT SPRING 11C Lode Mining Claim on this 2nd day of April, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

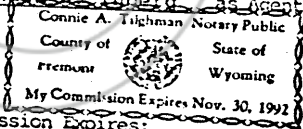
