CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HOT SPRING 115 Lode Mining Claim on this 2nd day of April, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SW(NW) (Quarter) Section(s) 18(19), Township 29 North, Range 49 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,
