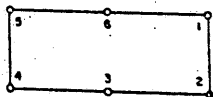
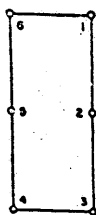

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HOT SPRING 122 Lode Mining Claim on this 2nd day of April, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the SE(NE) (Quarter) Section(s) 18(19), Township 29 North, Range 49 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 410 feet in a south direction to Post No. 2, marked - HOT SPRING 122-2
Thence, 410 feet in a south direction to Post No. 3, marked - HOT SPRING 122-3
Thence, 600 feet in a west direction to Post No. 4, marked - HOT SPRING 122-4
Thence, 410 feet in a north direction to Post No. 5, marked - HOT SPRING 122-5
Thence, 410 feet in a north direction to Post No. 6, marked - HOT SPRING 122-6
Thence, 600 feet in a east direction to Post No. 1, marked - HOT SPRING 122-1

the point of beginning and all monuments being Wood Posts.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a north direction and 810 feet in a south direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is north and south.
