THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HOT SPRING 139 Lode Mining Claim on this 3rd day of April, 1991, situated in the Unknown Mining District, Eureka County, Nevada.
