CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that NEWMONT EXPLORATION LIMITED, by its Agent, the undersigned, does hereby locate the HOT SPRING 159 Lode Mining Claim on this 3rd day of April, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NE(SE)(SW) (Quarter) Section(s) 15(10)(11), Township 29 North, Range 48 East, Mt. Diablo Mer., and is more particularly described as follows, to wit:
