CERTIFICATE OF RELOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that ATLAS CORPORATION, by its Agent, the undersigned, does hereby relocate the SI SI 44 Lode Mining Claim on this 7th day of June, 1991, situated in the Unknown Mining District, Eureka County, Nevada.

Said Claim is located in the NW(SW) (Quarter) Section(s) 2(2) Township 22 North, Range 50 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

The number of linear feet claimed in length along the course of the vein from the point of discovery is 20 feet in an east direction and 1448 feet in a west direction, together with 100 feet on each side of the center of the vein or lode for the entire length of the claim.

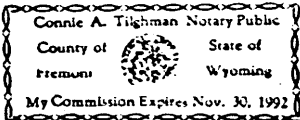
