The claim is 1500 feet long and 600 feet wide, and 150 feet is claimed in a NORTHERLY direction and 150 feet in a SOUTHERLY direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the NORTH to the SOUTH.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by MATERIAL TAG, SCREWBRE ON WOOD, SCREWBRE ON PLASTIC, YELLOW PLASTER MARKER.
