CERTIFICATE OF LOCATION OF LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that GREAT BASIN EXPLORATION CORPORATION hereby claims by right of discovery and location under and pursuant to the laws of the United States of America and the State of Nevada, the following described Lode Mining Claim, and in making this claim and for the purpose of establishing its right thereto, hereby certifies and states:

- 1. The name of the lode or vein is FRAZIER CREEK # 3.
2. The name of the locator and owner is GREAT BASIN EXPLORATION CORPORATION.
3. The date of location is the 31 st day of May, 1991.
4. The number of linear feet claimed along the course of the vein each way from the point of discovery, at which a discovery monument was erected and on which a notice of location was posted in accordance with applicable laws, is 1490 feet northerly and 10 feet southerly, which is the general course of the lode or vein so far as presently appears, and on the easterly side of the center of the vein 300 feet and on the westerly side of the center of the vein 300 feet.
5. Location work consisted of making the maps as provided by N.R.S. 517.040, attached hereto and by this reference incorporated herein.
6. The location and description of the corners, each monument at which being a wood post not less than 3 inches in diameter at least four feet in length set 1 foot in the ground.

(a) The claim is situated all or in part of the following quarter section(s): NW 1/4 Sec 1, T 24 N, R 51 E; Sec 1, T 24 N, R 51 E; Mount Diablo P.M., County of Eureka, State of Nevada, and more particularly described as follows, to wit:

(b) To tie this claim to the Public Survey, begin at the NE corner of section 1, T 24 N, R 51 E; Mount Diablo P.M., and bear south, 00 feet and bear west, 4200 feet to the NE corner, No. 1, a wood post. Thence, 750 feet in a southerly direction to monument No. 2, a wood post Thence, 750 feet in a southerly direction to monument No. 3, a wood post Thence, 600 feet in a westerly direction to monument No. 4, a wood post Thence, 750 feet in a northerly direction to monument No. 5, a wood post Thence, 750 feet in a northerly direction to monument No. 6, a wood post Thence, 600 feet in an easterly direction to monument No. 1, a wood post. The point of beginning, and all posts are marked with an inscribed metal tag.
