CERTIFICATE OF LOCATION OF LODE MINING CLAIM

NOTICE IS HEREBY GIVEN that GREAT BASIN EXPLORATION CORPORATION hereby claims by right of discovery and location under and pursuant to the laws of the United States of America and the State of Nevada, the following described Lode Mining Claim, and in making this claim and for the purpose of establishing its right thereto, hereby certifies and states:

1. The name of the lode or vein is FRAZIER CREEK # 80.

 - Thence, 750 feet in a southerly direction to monument No. 3, a wood post
 - Thence, 600 feet in a westerly direction to monument No. 4, a wood post
 - Thence, 750 feet in a northerly direction to monument No. 5, a wood post
 - Thence, 750 feet in a northerly direction to monument No. 6, a wood post
 - Thence, 600 feet in an easterly direction to monument No. 1, a wood post.
