

EXHIBIT "B"

GEOLOGICAL & GEOPHYSICAL SURVEY REPORT

August 21, 1991

This detailed report is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the Hawkeye #59(et al) & Hawkeye #1(et al) claims(see EXHIBIT "A"), a contiguous group of 145 lode mining claims situated in the Unknown Mining District of Eureka County, State of Nevada.

The work consisted of reconnaissance geological mapping of the entire claim block and geophysical exploration of the Hawkeye Claims Nos. 1 thru 15, 20 thru 25, 59 thru 77 to evaluate the discovery of valuable mineral deposits located thereon and to assist in planning further exploration and development work. The work was performed intermittently between the dates of June 1st and August 21st, 1991 by Bob Goodson of 169 Cedar Street, Elko, Nevada, a geologist of 12 years experience in exploration with a degree from Colorado State University(B.Sc. in Geology, 1979). The cost of the geological and geophysical surveys exceeded \$15,000.00 and was paid for by Earl and Jennie Allred, Herbert Hawkins, owners of the subject mining claims.

A VLF-H geophysical survey was made with a Geonics EM-16 unit manufactured by Geonics Limited on the above mentioned claims. The basic findings of this survey and the reconnaissance geologic mapping indicate that geologic factors similar to other known mineralized properties in the region occur within the boundaries of the subject mining claims. Many strong structures and several favorable host rock types were identified, all of which are apparently controlling the mineralization within the subject mining claims.

An exploration-development program consisting of further geological, geochemical and geophysical surveys is being considered for this property. These surveys would be followed by detailed trenching, drilling and sampling. All technical work and results are in the possession of Bob Goodson, geologist and agent for the owners of the subject mining claims.
