18 property, real or personal, of any name, nature, kind, character

22 encumbrances to exceed \$25,000.00, is assigned and set aside to:

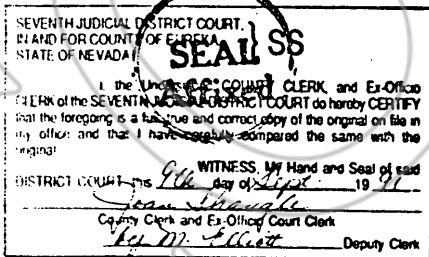
