11 \$10.00 to it in hand paid by the party of the second part,  
12 EUREKA COUNTY, the receipt whereof is hereby acknowledged, does  
13 by these presents grant, bargain and sell unto the party of the  
14 second part, EUREKA COUNTY, its heirs and assigns forever, all  
15 that certain lot, piece or parcel of land situate, lying and  
16 being in the County of Eureka, State of Nevada and more  
17 particularly described as follows, to wit:

18 South 34 feet of Lot 8, Block 73, lying and being in the  
19 Town Site of Eureka, County of Eureka, State of Nevada.  
20 together with all and singular the tenements, hereditament, and  
21 appurtenances thereunto belonging or in anywise appertaining,

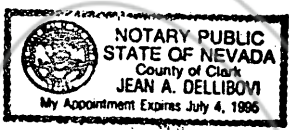
