Dear Mr. Ithurrealde:

Enclosed is the form for agricultural exemption which you requested.

We are presently leasing our property to Sestenovich Ranching of Pine Valley and Diamond Valley. You have access to their financial records regarding gross income from agricultural operations. I do not have access to these records, but presume gross income is at least \$100000 per annum.

On the basis that we are providing half the annual feed for cattle that are sold for more than \$10000, I believe that we meet the requirements for an agricultural taxation rate.

Historically, our property has been used exclusively for agricultural purposes since 1860, and continues to be so used. If an agricultural evaluation should be considered not appropriate at this time, than we request an official hearing on this matter.

We appreciate your consideration of our status and would be glad to meet with you at your convenience. Please advise.
