That, for and in consideration of the sum of ONE HUNDRED TWENTY THREE THOUSAND SIX HUNDRED THIRTY ONE and 13/100 (\$123,631.13) DOLLARS, and other good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned, Co-Executors of the ESTATE OF BATTISTA TOMERA, JR., aka BATTISTA TOMERA, aka BUTCH TOMERA, do hereby grant, bargain, convey and assign unto GEORGE TOMERA, Box 486, Carlin, Nevada 89822, all of Decedent's right, title, interest and estate belonging to BATTISTA TOMERA JR., or his Estate, in and to a Deed of Trust, dated February 28, 1986, executed by JULIAN TOMERA RANCHES STONEHOUSE DIVISION, a Nevada Corporation, as Trustor for TOMERA BROTHERS, a Nevada General Partnership, Beneficiary.

Said Deed of Trust describes real property located in both Elko and Eureka Counties, Nevada and was recorded May 16, 1986 at Book 523, Page 661, as File Number 215463, Official Records of Elko County Recorder's Office and June 23, 1986, at Book 145, Page 534 as File Number 103377, Official Records of Eureka County Recorder's Office.

A. ELKO COUNTY:

1. BATTISTA TOMERA JR., died on September 6, 1988; his Estate is currently being probated by the Fourth Judicial District Court, in and for the County of Elko, State of Nevada. 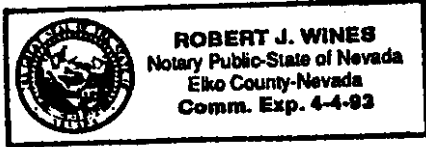

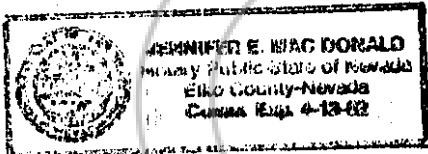
