This detailed report is filed for the year 1990-1991 in compliance with the requirements of Title 30, United States Code, Section 28-1 for the HCS 1-218 unpatented lode mining claims situated in the unknown Mining District of ~~Eureka~~ County, Nevada.

The work performed consisted of the geochemical analysis of 925 samples which resulted from reverse circulation rotary drilling. Samples were analyzed for gold, silver, arsenic, mercury, antimony, aluminum, barium, beryllium, bismuth, cadmium, calcium, cobalt, chromium, copper, iron, gallium, potassium, lanthanum, magnesium, manganese, molybdenum, sodium, nickel, phosphorus, lead, scandium, strontium, titanium, uranium, vanadium, tungsten, and zinc. Additional work included geochemical logging of drill holes and interpretation of various lithologies based upon chemistry.

The results of the work indicate that the Horse Canyon South property is geologically favorable to host bulk mineable gold deposits in lower plate rocks beneath the Roberts Mountains thrust.

The work was performed by Patrick Cavanaugh, ECM's geologist and by Gary Massingill and Ron Parrat, geologists with Santa Fe Pacific Mining, Inc. Mr. Cavanaugh has a M.S. degree in geology from the University of Montana, and approximately 18 years experience in metals exploration. Both Mr. Parrat and Mr. Massingill have degrees in geology and considerable experience in the mining industry.

All results of these geological surveys are in the possession of ECM Inc., P.O. Box 3493, Billings, Montana 59103.
