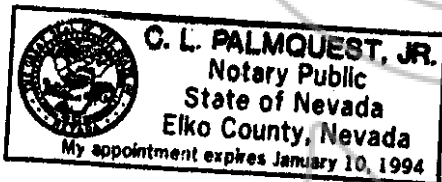

This detailed report is filed in compliance with the requirement of Title 30, United States Code, section 28-1 for the Joe 1-17, 22 contiguous unpatented claims, situated in Eureka County, State of Nevada.

The work consisted of a gravity survey to evaluate the potential of the claims for discovery of valuable mineral deposits thereon and to assist in planning further exploration, development, and extraction of minerals. The work was performed under the supervision of James L. Wright, Elko, Nevada a professional geophysicists employed by Newmont Exploration Limited, P.O. Box 669, Carlin, Nevada 89822. The work was completed by the following individuals who are geophysicists/geologists employed by Newmont Exploration Limited during the work period.

Mr. James L. Wright has a Masters of Science Degree from Stanford University.

Mr. David Matherly has a Bachelor of Science Degree from Ball State University.

The geophysical work consisted of a gravity survey with twenty-two (22) stations, and a station spacing of approximately 500 ft.

The cost of the work exceeds \$1000.00 and was conducted at the expense of Newmont Exploration Limited.

Bouguer gravity readings range from -176.31 to -177.74 milligals (mgal) with a Bouguer density of 2.67 g/cc. and a datum subtracted of 978,000 mgals. The values drop from the north to south across the claim block.

All technical work and results are in the possession of Newmont Exploration limited, the owner or lessor of the subject claims.
