- 3. That the above claims are owned by Wilson Mineral Properties, Inc., a Nevada corporation, and that said claims are contiguous and have been consolidated into one group for the purpose of common development.
- 4. That the work consisted of rock chip sampling, stream sediment sampling and assays, and geological type work. In compliance with the requirements of Title 20 United States Code 28-1, the following summary report is filed relating to geological type work.

The work, performed during August 1991, consisted of detailed geological and geochemical surveys performed by Michael Coleman, David Fitch, and Michael Turner, consulting and staff geologists for Pathfinder Gold Corporation. The personnel are all geologists holding degrees in Geology from accredited universities; each with in excess of 15 years experience in the Mining Industry.

The cost of the geological and geochemical studies, together with the physical work completed, exceeds \$6,000. The basic findings of the study are as follows:

A two-thousand foot long breccia zone was defined within the SW4 of Section 29, T24N, R50E. The zone consists of silicified brecciated Cambrian carbonates occurring along a high angle front range fault striking N60°E. The rocks contain anomalous gold, arsenic and antimony. The values are similar to rock chip geochemistry associated with the nearby Tonkin Springs and Gold Bar gold deposits.

These studies enhance knowledge of the controls to mineralization in the area, thereby providing and encouraging a more informed basic for future exploration and development for an economic mineralized deposit.

All technical work and results are in the possession of and are considered to be the exclusive property of Pathfinder Exploration Corporation and Wilson Mineral Properties Inc.

5. That the above work, valued in excess of ONE HUNDRED DOLLARS (\$100.00) per claim, has been expended on the above claims and that this work develops or tends directly to develop the mineral resources and the exploration thereof and facilitates and leads to the extraction minerals therefrom.


