The patented mining claims are situated in the Lynn Mining District, County of Eureka, State of Nevada. The work was done during the assessment work period ending with the period January 1 - August 31, 1991. That the owner of these patented mining claims is Newmont Gold Company as set forth as Exhibit A attached hereto.

Said work was done at the expense of Newmont Gold Company, the owner of said patented mines or mining claims, for the purpose of relieving the same from tax assessment.

The work was performed by Newmont Gold Company, Newmont Exploration Limited, and others over the entire claim group.

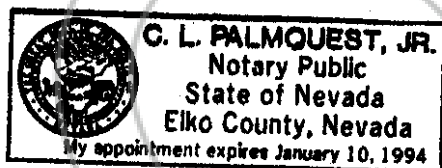
