
Said work was done at the expense of Newmont Gold Company, the owner of said patented mines or mining claims, for the purpose of relieving the same from tax assessment.

The work was done continuously during the January 1 - August 31, 1991 period, and work is continuing at this date.



This information was utilized in developing a 200 ft. spaced network of north-south and east and west cross sections as the frame-work to the current Carlin Mine resource and reserve model.

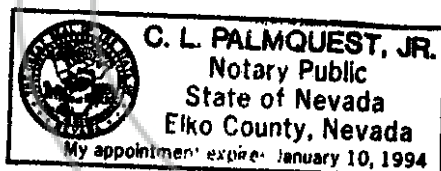
