IN WITNESS WHEREOF, the Grantor has executed this Quitclaim Deed effective the day and year first above written.



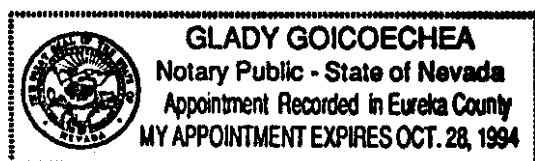
